ICC Member, ICC-ES Accept WSSPC Awards

Ron Lynn, Director/Building Official for the Clark County, Nev., Department of Development Services and a past International Code Council (ICC) President and **Shahin Moinian**, P.E., President, ICC Evaluation Service (ICC-ES) attended the [Western States Seismic Policy Council](#) (WSSPC) Awards Luncheon, held July 21 in Anchorage, Alaska, where they were honored as award recipients.

Lynn received one of only two [WSSPC 2014 Lifetime Achievement Awards in Earthquake Risk Reduction](#). Moinian accepted the [WSSPC 2014 Non-Profit Agency Efforts Award in Excellence](#) for recognition of the ICC-ES Evaluation Report Program.
