- 1. The applicant will promptly inform ICC-ES if there is any significant change to certified products.
- 2. The applicant will reimburse ICC-ES for expenses incurred in obtaining samples of certified products, and having products retested, whenever retesting is required by the ENERGY STAR program.
- 3. The applicant agrees, in the event of required retesting, to cooperate with ICC-ES in sample selection. If ICC-ES wishes to obtain samples at client-controlled warehouse, the applicant will provide ICC-ES with the necessary access. If ICC-ES wishes to purchase samples on the open market, the applicant agrees to provide ICC-ES with the locations of at least three outlets, close to an ICC-ES office location, where the product may be purchased.
- The applicant acknowledges reviewing applicable documents describing the ICC-ES ENERGY STAR certification
 program, and the ICC-ES Fee Schedule. The applicant also agrees that ICC-ES may, as necessary, subcontract for
 work related to the product certification process.
- 5. The applicant agrees to abide by the requirements of the EPA ENERGY STAR program and any conditions attached to the approval of this application, as they now exist and as they may be reasonably modified in the future.
