Standards Council of Canada Expands ICC-ES PMG Scope Accreditation

Expanded scope will allow more manufacturers to distribute products in Canada following certification

The [Standards Council of Canada](#) (SCC) has granted the [ICC Evaluation Service](#) (ICC-ES) Plumbing, Mechanical and Fuel Gas (PMG) program a scope expansion for gas products. The scope expansion for the existing capability allows the [ICC-ES PMG program](#) to certify fuel gas products for the Canadian market. The expanded scope has long been accredited in the United States by the American National Standards Institute (ANSI).
