Under the PMG program, benefits for new applicants include the "Transfer and Save" Program for Plastic Pipe and Fittings manufacturers, and an opportunity to save up to 40percent on product certification costs. The PMG program also simplifies the product certification process, by offering certification to the International Codes and all other applicable codes and standards in one file by one internationally recognized certification agency.
