**8. AGREEMENT AND SIGNATURE:**

- a. Applicant acknowledges reviewing applicable ICC-ES Rules of Procedure, and that the applicant shall be responsible for ensuring that products covered by this application conform with ICC-ES product certification requirements. The applicant agrees that all communications between ICC-ES and the applicant prior to issuance of a final listing report, including draft listing reports and comments thereto, are and shall be the exclusive property of ICC-ES.
