It is produced in rolls of varying sizes and has a nominal weight of 1.92 ounces per square yard. KS Premiumwrap is a woven, perforated, polyolefin fabric with a polymeric coating on both sides. It is produced in rolls of varying sizes and has a nominal weight of 2.21 ounces per square yard. Both were evaluated when tested to the following

standard:

ASTM E84 (-16), Standard Test Method for Surface Burning Characteristics of Building Materials, ASTM

International.

KS Housewrap and KS Premium Weather-Resistive Barriers have a flame-spread index of 25 or less and a smoke-developed index of 450 or less (Class A), based on testing in accordance with ASTM E84, as

referenced in the applicable sections of the following code editions:
