Sound Build Inc. AirKrete Type SB pumped-in-place insulation was evaluated when tested at the nominal inplace density and thickness specified below, when tested to the following standards:

- ASTM E84 (-2018B), Standard Test Method for Surface Burning Characteristics of Building Materials, ASTM International.
- UL 723 (-2018), Standard for Test for Surface Burning Characteristics for Building Materials, UL Laboratories, Inc.

Findings:

Sound Build Inc. AirKrete Type SB pumped-in-place insulation, at a thickness of 4 inches (102 mm) and an in-place density of 5.5 lb/ft³ (88 kg/m³), with or without a polypropylene fabric facer, has a flame-spread index of 25 or less and smoke-developed index of 450 or less, based on testing in accordance with ASTM E84 / UL 723, as referenced in the applicable sections of the following code editions:

- 2021 International Residential Code[®]
 Applicable Section: R302.10.1
