1.0 EVALUATION SCOPE

Compliance with the following codes:

- 2015, 2012, and 2009 International Building Code® (IBC)
- 2015, 2012, and 2009 International Residential Code® (IRC)

Property evaluated:

■ Penetration Firestopping

2.0 USES

The CorPlug system is used as a through-penetration fire stop system, in accordance with 2015 IBC Section 714.4.1.2 (2012 IBC Section 714.4.1.1.2 and 2009 IBC Section 713.4.1.1.2) and IRC Section R302.4.1.2, to fill and seal a round opening left by the removal of a previously installed through-penetration firestop system in an existing one- or two-hour fire-resistance-rated, 3.5-inch-thick concrete floor-ceiling assembly. When installed in accordance with this report, the CorPlug system as an F rating/T rating of 1 hour or 2 hours.

3.0 DESCRIPTION

3.1 General:

The CorPlug system consists of a 3.5 inch (89 mm) deep, concrete-type, solid truncated cone with a partially embedded, bent steel rod and an intumescent sealant. The system is designed to seal round openings in fire-resistance-rated floor-ceiling assemblies as shown in <u>Figure 1</u>. The CorPlug is available in the models and sizes specified in <u>Table 1</u>.

3.2 3M Fire Barrier Sealant CP 25WB+: The 3M Fire Barrier Sealant CP 25WB+ is a latex-based, intumescent, single-component sealant. The sealant is packaged in 10-fluid-ounce (296 ml) cartridges, 20-fluid-ounce (591 ml) sausages, 27-fluid-ounce (798 ml) cartridges, 2-gallon (7.6 L) pails and 5-gallon (18.9 L) pails. The sealant has a shelf life of 12 months when stored in original unopened containers and stored indoors in dry conditions between 68°F and 90°F (20°C and 32°C).

4.0 DESIGN AND INSTALLATION

4.1 General:

Installation of the CorPlug system must comply with this report, the manufacturer's published installation instructions and the applicable code. The report holder's published installation instructions are to be available at the jobsite at all times during installation.

4.2 Substrate Preparation:

The opening and adjacent surfaces in the concrete floor-ceiling assembly must be clean and free of contaminants, such as dirt, dust, oil, moisture, grease and wax, that may inhibit adhesion or curing of the sealant.

4.3 Application:

The system must be installed as shown in Figure 1. A $\frac{1}{2}$ -inch (12.7 mm) diameter bead of the 3M Fire Barrier Sealant CP 25WB+ must be applied to the circumference of the concrete opening $\frac{1}{2}$ inch (12.7 mm) below the top surface of the concrete and a $\frac{1}{2}$ inch (12.7 mm) diameter bead of the sealant must be applied to the circumference of the solid truncated cone $\frac{1}{2}$ inch (12.7 mm) from the bottom of the cone, to fill the annual space between the CorPlug and the edge of the opening in the concrete floor-ceiling assembly when the CorPlug system is installed.

5.0 CONDITIONS OF USE:

The CorPlug system described in this report complies with, or is a suitable alternative to what is specified in, those codes listed in Section 1.0 of this report, subject to the following conditions:

- **5.1** Materials and methods of installation must comply with this report, the report holder's published installation instructions and the applicable code. In the event of a conflict between the report holder's published installation instructions and this report, this report governs.
- 5.2 Fire-resistance-rated floor-ceiling assembly must comply with the applicable code.

6.0 EVIDENCE SUBMITTED

- **6.1** Reports of testing in accordance with ASTM E814 and an engineering analysis.
- 6.2 Quality documentation.




