# 1.0 EVALUATION SCOPE

#### Compliance with the following codes:

- 2024, 2021 and 2018 International Building Code® (IBC)
- 2024, 2021 and 2018 International Plumbing Code® (IPC)
- 2024, 2021 and 2018 International Residential Code® (IRC)

#### **2.0 USES**

DMX Tile Membrane is a waterproofing membrane for use on concrete floors as a barrier in bonded thin-set installation of code-approved ceramic tile and dimension stone. The membrane is also used as a shower subpan lining in accordance with IPC Section 421.5.2; and as a lining material in accordance with Section P2709.2 of the IRC.

# 3.0 DESCRIPTION

**3.1 DMX Tile Membrane:** DMX Tile Membrane is made from rigid high density polyethylene plastic. The plastic membrane has circular dimples spaced in a symmetrical layout and has thickness of 120 mils [0.12 in. (3 mm)]. The dimples have a height of 0.10 -inch (2.5 mm) and are fused to a fleece type fabric. The rolls come in at 3.25 feet (991 mm (990 mm) wide and 15.7 feet (4.8 m) in length.

#### 3.2 DMX Vapor Band:

DMX Vapor Band is an accessory that is used with DMX Tile Membrane in accordance with the manufacturer's published installation instructions. The accessory is a waterproofing strip, designed to seal joints and protection against moisture. DMX Vapor Bands are 16 feet (5 m) long and 5 inches (12.5 cm) in wide.

# 4.0 INSTALLATION

Installation of DMX Tile Membrane and accessory must comply with this report and the manufacturer's published installation instructions. The manufacturer's published installation instructions must be available at the jobsite at all times.

The membrane is suitable for use with any bonded, thin-set mortar without the need for additional adhesives or primers.

The membrane is separated at expansion joints to avoid destruction of the joint movement, and the seams are sealed with flexible DMX Vapor Band.

# **5.0 CONDITIONS OF USE:**

DMX Tile Membrane described in this report complies with, or is a suitable alternative to what is specified in, those codes listed in Section 1.0 of this report, subject to the following conditions:

- **5.1** Installation must comply with this report, the manufacturer's published installation instructions and the applicable code. In the event of a conflict between the manufacturer's published installation instructions and this report, this report governs.
- **5.2** This report is limited to evaluation of the membranes for interior use. Other applications are outside the scope of this report.
- **5.3** DMX Tile Membrane and accessories are produced under a quality control program with inspections by ICC-ES.
