- a) The manufacturer's recognized name, trademark, or other mark; or
- b) In the case of private labeling, the name, trademark, or other mark of the customer for whom the fitting was manufactured.
- c) The ICC-ES PMG listing mark

Markings shall be accomplished by use of a permanent mark or by placing a permanent label on the product. Markings shall be located in such a way that they are visible after installation.

Packaging shall be marked with:

- a) The manufacturer's recognized name, trademark, or other mark as well as the model number; or
- b) In the case of private labeling, the name, trademark, or other mark of the customer for whom the fitting was manufactured as well as the model number.
- c) The manufacturer's specified maximum flow rate in L/min and gpm or L/cycle and gpc.
