Identification:

Each fixture shall be marked with the manufacturer's name or registered trademark or, in the case of private labelling, the name of the customer for whom the fixture was manufactured so as to be visible after installation and the ICC-ES PMG listing mark (packaging acceptable).

Bathtub and shower bases that use field-installed flanges shall have a non-permanent label stating "Do not install this fixture against a wall unless the appropriate flange is first installed."

Packaging shall be marked with the manufacturer's name and/or trademark or, in the case of private labelling, the name of the customer for whom the fixture was manufactured and model number

Installation:

Fixtures are to be installed in accordance with the manufacturer's installation instructions and the applicable code. Flange kits for installation in the field shall include installation instructions.
