#### Identification:

Product shall be clearly labelled. The label shall include at a minimum the manufacturer's name or Trademark as well as the ICC-ES PMG certification mark.

### Installation:

Redgard<sup>®</sup> Fabric Membrane shall be installed in accordance with the manufacturer's published instructions and the applicable code(s).

Ceramic tile must comply with ANSI A137.1

When provided with a clamping ring with open weep holes, the drains shall be installed in accordance with ASME A112.6.3 or ASME A112.18.2 (latest edition) as applicable.

<u>Redgard® Fabric Membrane:</u> Composite sheet membrane comprised of an inner layer of polyethylene between two outer layers of polypropylene nonwovens.

<u>Redgard® Fabric Membrane Corners</u>: Pre-formed interior and exterior angles constructed from the Redgard® Fabric Membrane.

<u>Redgard<sup>®</sup> Wall and Floor Gaskets</u>: Flashings for pipe and drain penetrations formed from an interior layer of thermoplastic elastomer and two exterior polypropylene nonwovens.
