1.0 EVALUATION SCOPE

Compliance with the following criteria:

- EC118 ICC-ES Environmental Criteria for Safe and Sustainable Cabinetry (SASC); September 2023 – **Green Level**

Compliance eligibility with the applicable sections of the following green building rating systems, standards and codes:

- National Green Building Standard (ICC 700-2020, ICC 700-2015, and ICC 700-2012) (See Table 1 for details).
- 2022 California Green Building Standards Code (CALGreen), Title 24, Part 11 (See Table 2 for details).
- ANSI/GBI 01-2021 - Green Building Assessment Protocol for Commercial Buildings (See Table 3 for details).
- 2021 and 2018 *International Green Construction Code* (2018 IgCC) (See Table 4 for details).
- ANSI/ASHRAE/ICC/USGBC/IES Standard 189.1- 2020 and 2017 (ANSI/ASHRAE/USGBC/IES Standard 189.1-2014) – Standard for the Design of High-Performance Green Buildings, Except Low-Rise Residential Buildings (See Table 5 for details).

2.0 USES

Cabinetworks Group Inc.'s kitchen and vanity cabinets are used for a variety of interior applications including use in kitchens and bathrooms.

3.0 CABINET PERFORMANCE AND SUSTAINABILITY ATTRIBUTES

3.1 Biobased Content:

Cabinetworks Group Inc.'s kitchen and vanity cabinets are manufactured from biobased materials, which includes various species of solid wood and types of engineered wood such as particle board, plywood, and MDF.

3.2 Formaldehyde Emission Compliance:

The raw particleboard, plywood, and MDF materials used in manufacture are certified for compliance with EPA TSCA Title VI, 15 U.S.C. 2697 formaldehyde standards, and section 93120 California Code of Regulations (CARB ATCM) or are exempt from certification requirements.

3.3 Performance and Construction:

Cabinetworks Group Inc.'s kitchen and vanity cabinets are certified for compliance with the ANSI A161.1-2022 Performance and Construction Standard for Kitchen and Vanity Cabinets; see ICC-ES listing [PMG-1689](#).

4.0 MANUFACTURING SUSTAINABILITY ATTRIBUTES

The Cabinetworks Groups Inc.'s manufacturing facilities have been verified to implement the following programs in accordance with the ICC-ES Environmental Criteria for Safe and Sustainable Cabinetry (SASC) [EC118]:

- 4.1 Greenhouse Gas (GHG) emissions measurement programs in accordance with the U.S. Environmental Protection Agency Greenhouse Gas Inventory Guidance documents.
- 4.2 Tracking of water consumption used in manufacturing.
- 4.3 Tracking of the total amount of hazardous and non-hazardous waste produced at each facility.
- 4.4 Tracking of the total amount of waste that is recycled and / or repurposed, and verification that a minimum of 51% of all waste generated is recycled and / or repurposed.

5.0 CONDITIONS
